

# Elev8 Contractual Partnership Request for Information

**Elev8 Baltimore Mission**: Elev8 Baltimore partners with schools, families, and the community to ensure that every student is prepared for high school, college, career, and life.

**Elev8 Commitment to Liberation and Equity**: Elev8 Baltimore works to create liberating opportunities for youth and communities that have been oppressed by white supremacist structures and systems. We build committed partnerships with other organizations to provide training and tools for youth to advocate for themselves and bring equity to their communities.

**About Elev8 Baltimore**: Launched in 2009, Elev8 has been partnering with schools as a community school lead agency partner since 2009. In the past year, Elev8 Baltimore has increase from serving as the lead agency partner for 10 schools to 15 schools, launched South Baltimore Adult High School, a community school serving adults 21 and older, and launched high-dosage tutoring in nine schools. In addition to our partnership to support community schools, Elev8 also offers a comprehensive afterschool program in eight schools and programs for students in grades second through twelfth. Our schools serve a predominately Black population and are nearly all identified as Title I.



# **Mentoring Consultant Service:**







Elev8 Baltimore seeks to launch a pilot of our mentoring program based on <u>Success Mentors</u> and <u>Amachi Mentoring Program</u> (no more than 5 volunteers per school and 10 students per school) by February 2023. The basics of the program would need to apply for students in grades 2 ranging to over-aged, under-credited, and sometimes incarcerated youth.

The consultant would have the following scope:

- Develop program calendar and project plan
- Develop necessary materials -- Curating and Modifying Publicly Available Materials Is Acceptable. This includes but is not exclusive of:
  - Staff and Volunteer Job Descriptions
  - o Training Materials (For Elev8 Staff and Volunteers)
  - School Commitments
  - Mentor and Student Recruitment Materials
  - Requisite Data Tracking Forms
  - o Curriculum Materials and verification that Elev8 will have access to them at no additional cost in future years.
  - Schedules
- Develop and deliver initial training for the programming and execute a second training for staff members in summer of fall 2023
- Regular meeting with Elev8 staff regarding the project and the ability to make revisions based on Elev8 feedback.

The maximum budget for the project is \$10,000 and the goal will be for Elev8 to independently run the program after training in Fall 2023.

# **Power Parent Academy Expansion:**

Elev8 Baltimore seeks to augment its Power Parent Academy by implementing a multi-week curriculum that empowers and transforms families by providing the knowledge and the skills to partner with schools and communities to ensure their students achieve their full potential.

Our goal would be to launch a pilot in three schools in February 2023 and expand the program to nearly all of our partner schools in Fall 2023.

The consultant would have the following scope:

- Develop a project plan and the resources for Elev8 to develop a program calendar
- Provide an evidence-based curriculum (supporting parents from 2<sup>nd</sup>-8<sup>th</sup> grade), the materials needed to implement it, and this includes but is not exclusive of:
  - Staff Job Descriptions
  - o Training Materials (For Elev8 Program)
  - School Commitments
  - Staff and Parent Recruitment Materials and Methodology
  - Requisite Data Tracking Forms
  - Curriculum Materials and verification that Elev8 will have access to them at no additional cost in future years.
  - The ability for Elev8 to modify or amend program materials to align them with the needs of our communities and organization.
  - o Program schedules
- Develop and deliver initial training for the programming and execute a second training for staff members in summer of fall 2023. The goal would be for Elev8 to run the program independently after the final training.

Potential topics for the weekly curriculum include:

- Structural racism and how historic redlining as influenced the education, housing, transportation, and workforce systems locally and nationally
- Strategies to build student's positive self-esteem
- Tools to navigate the school system
- Prepare a college-going plan
- GPA
- Student workload and expectations
- Common Core State Standards (CCSS)
- Working with the school counselor

We seek to partner with enrichment partners that expand student horizons in science, technology, engineering, the arts, mathematics, cultural exploration, foreign language, social justice, athletics, and student expression. We value partners that expose students to in demand, family sustaining wage careers that they can be passionate about.

We will use the responses to this request for information to determine programming partnerships for the remainder of the year, our summer Freedom School program, and our Out of School Time Programming in SY 2023-24.

# **Billing and Invoicing Guidelines**

# ALL INVOICES MUST INCLUDE THE FOLLOWING INFORMATION

- The document should be on company letterhead
- The document must be titled "Invoice" and include the vendor's legal name and contact information, including a full mailing address, phone, and email. If applicable a separate remit address should be included. Legal name should match the name listed on your W-9.
- A unique invoice number that has never been used with Elev8 Baltimore.



- The name of the school / site in which services are being provided. If you are serving multiple sites, a separate invoice for each site is required.
- Dates of service for the invoice (amount billed for services completed during specific period)
- Description of work that includes the services to be provided under this invoice
- Total Amount Due Breakout must be consistent with the hourly rate listed in the partner's / vendor's quote or proposal. Failure to align the invoice with the rates listed in the original quote or proposal may result in non-payment of the invoice.

**Invoices are paid Net 30** – Elev8 will pay the partner / vendor, upon submission of proper invoices, the prices stipulated in the contract for services rendered and accepted within 30 days of receiving a proper invoice.
